

Results of the 21st Selection Exercise (November 2011) on the “Quality Migrant Admission Scheme”

70 applicants have been allocated quotas in the 21st selection exercise. They will be issued with "Approval-in-principle letters", and be invited to come to Hong Kong for an interview to present originals of all documents submitted during the application to the Immigration Department for verification. **An Approval-in-principle is not a formal approval of an entry visa/entry permit under the Quality Migrant Admission Scheme.** These applicants must fully satisfy the Immigration Department that all statements made or information provided during the application are true and complete before a formal approval can be granted.
