



由二零零三年年中開始，市民可獲簽發智能身份證。智能身份證如一般信用卡大小，植有可儲存和處理資料的晶片。除供作與入境事務有關的用途外，智能身份證亦可支援其他非入境事務的用途，包括香港郵政電子證書和香港公共圖書館圖書證。市民可自由選擇是否申請使用這些非入境事務的增值用途。

重要事項

請愛惜你的智能身份證——請緊記智能身份證是你的重要身份證明文件。它是耐用可靠的物料製成，但如不妥善保護，仍會損毀。因此，請把智能身份證存放在合適的保護套內。切勿摺曲或以磁石觸碰智能身份證，或把身份證與鑰匙或硬幣等放在一起。使用電子證書功能時，亦請勿搓刮晶片，應盡量使用「下落式接觸」閱讀器，確保不會與晶片摩擦。切記不可拆出智能卡內的晶片；如拆出晶片，身份證上的電子功能便會即時失效。

確定程序——如你的智能身份證是由他人代領，你須親身前往入境事務處的自助服務站，使用智能身份證閱讀機，以確認你智能身份證內所儲存的個人資料。

遺失智能身份證——你須於14天內親身前往任何一間人事登記辦事處補領新證。若你遺失的身份證已儲存香港郵政電子證書或你已登記該證作公共圖書館圖書證用途，你可在任何一間人事登記辦事處填妥遺失通知書，並將該通知書放入適當的投遞箱內，以便有關機構或部門收取。

智能身份證閱讀機

功能

- 首次確認智能身份證晶片內所儲存的個人資料〔如身份證是由獲持證人授權的人代領〕[註]
- 查閱智能身份證晶片內所儲存的個人資料
- 查閱智能身份證晶片內所儲存的香港郵政電子證書的資料及更改個人密碼〔如持證人已選擇載入電子證書〕
- 更新智能身份證晶片內所儲存的逗留條件及／或逗留期限〔如持證人是受逗留條件限制的香港居民〕

註：簽發給身在海外的香港居民的香港永久性居民身份證，及因申領香港特區護照而簽發給11歲以下兒童的香港永久性居民身份證，無須進行這項確定程序。

Hong Kong Special Administrative Region Smart Identity Card



Starting from mid 2003, smart identity (ID) cards are issued to residents in Hong Kong. The smart ID card, in the size of a standard credit card, is embedded with a “chip” which can support the storage and processing of data. Apart from immigration applications, the smart ID card can also support other non-immigration applications, including Hongkong Post e-Cert and library card of the Hong Kong Public Libraries. At your free choice, you can apply to opt in these non-immigration applications.

Important Notice

Treasure your smart ID card at all times – the smart ID card is an important identification document. Though made of a very secure base material, it can be damaged if you do not protect it properly. Hence, you are advised to keep your smart ID card in an appropriate protective holder. You should not bend your smart ID card or put a magnet against it. Neither should you place your smart ID card together with key chains or coins. When using the e-Cert in the smart ID card, please avoid scratching the chip, and if possible, use a soft-landing type of smart card reader which will not cause any friction with the chip. Never try to detach the chip from the card. It will not function any more once the chip is removed.

Confirmation process – if your smart ID card is collected by another person on your behalf, you have to go to the Immigration self-service kiosk in person to confirm through a smart identity card reader the personal data stored in the chip of your smart ID card.

If you have lost your smart ID card – you should apply for a new ID card at any of the Registration of Persons Offices within 14 days. If your card carries a Hongkong Post e-Cert or if you have registered your smart ID card for library card function, you may report the loss by completing a report loss notification form available at any of the Registration of Persons

Offices and place it into the corresponding drop-in box for collection by the relevant agency or department.

Smart Identity Card Readers

Functions

- Confirm the personal data stored in the chip of the smart ID card for the first time (if the card is collected by an authorised person) *(Note)*
- View the personal data stored in the chip of smart ID card
- View the content and change the Personal Identification Number [PIN] of the Hong Kong Post e-Cert (if the cardholder has opted for one)
- Update the condition of stay and/or limit of stay (if the cardholder is a Hong Kong resident subject to a condition of stay)

Note : This confirmation process is not required for permanent identity card issued overseas and permanent identity cards issued to persons under the age of 11 in connection with their applications for HKSAR passports.
