Notes:

The information on visa-free access or visa-on-arrival and duration of stay will generally be updated upon receipt of written notification from the receiving country/territory, and is intended for general reference only. Due to the time required for exchange of correspondences, HKSAR passport holders are advised to check with the relevant local consulate or officially recognised representatives or the nearest embassy or consular post of the country/territory concerned in our country for accurate and up-to-date information before visiting the country/territory. The decision to grant or refuse a passenger's permission to enter a country/territory and the duration of stay given are usually determined on individual merits by the immigration authorities concerned on arrival.

Remark 1 : Holders of HKSAR passport can enter and stay without visa in the Republic of Albania for 90 days out of a 180-day period from the date of first entry.

Remark 2 : According to the information provided by of the Government of the Republic of Angola (Angola), HKSAR passport holders may visit Angola visa-free for a stay of up to 30 days and a maximum stay of 90 days per year.

Remark 3 : HKSAR passport holders do not need a visa to the Schengen area for a stay up to 90 days in any 180-day period. For details on the stay period in the Schengen area, please refer to the website: https://home-affairs.ec.europa.eu/policies/schengen/visa-policy_en.

Remark 4 : HKSAR passport holders can apply for a visa upon arrival for a stay of up to 14 days in Bahrain. HKSAR passport holders are also eligible to apply for E-visas to visit Bahrain prior to the visit. For details, please refer to the website: www.evisa.gov.bh.

Remark 5 : To be determined by the competent authorities upon arrival.

Remark 6 : According to the Embassy of Plurinational State of Bolivia in the People's Republic of China, holders of the HKSAR passports can apply for the tourist visa upon arrival in Bolivia for a stay of 30 days. For more information on the documents required and applicable fees as well as other details, HKSAR passport holders are advised to refer to the website: <http://www.embolchina.cn/index.php/English> before travelling to Bolivia.

Remark 7 : According to the information provided by the Government of Canada, starting from 15 March 2016, visa-exempt foreign nationals (including holders of HKSAR passport) who fly to or transit through Canada by air will require an Electronic Travel Authorization (eTA) prior to check-in for flight. Entry requirements for other methods of travel (land, sea)

have not changed. For details, please refer to the website: https://www.canada.ca/en/immigration-refugees-citizenship/services/visit-canada/eta.html?utm_source=slash-eta_ave&utm_medium=short-url-en&utm_campaign=eta. In case of enquiry, HKSAR passport holders are advised to consult the Consulate General of Canada in Hong Kong before travelling.

Remark 8 : HKSAR passport holders can apply for a visa upon arrival. HKSAR passport holders are advised to consult the relevant embassy or consulate for detailed information before travelling.

Remark 9 : HKSAR passport holders can apply for a visa upon arrival at the Bole International Airport in Addis Ababa.

Remark 10 : Visa-free access to Guam took effect on 28 November 2009. HKSAR passport holders are also required to present their valid Hong Kong permanent identity cards upon arriving in Guam.

Remark 11 : HKSAR passport holders can apply for a visa upon arrival to the Republic of Guyana. For details, please refer to the website: <http://www.minfor.gov.gy/>.

Remark 12 : Starting from 1 September 2025, in the pilot phase, all international passengers (including HKSAR passport holders) arriving at Soekarno-Hatta International Airport, Ngurah Rai International Airport and Juanda International Airport in Indonesia are required to complete the declaration through “All Indonesia” digital declaration system within three days before arrival. This requirement will be extended to all international airports in Indonesia starting from 1 October 2025. For details, please refer to the website: <https://allindonesia.imigrasi.go.id/>. In case of enquiry, HKSAR passport holders are advised to consult the Consulate General of Indonesia in the HKSAR before travelling.

Remark 13 : Starting from 1 January 2025, visitors from visa-exempt countries (including holders of HKSAR passport) are required to obtain an Electronic Travel Authorization (ETA-IL) approval before entering Israel. For details, please refer to the website: <https://israel-entry.piba.gov.il/>. In case of enquiry, HKSAR passport holders are advised to consult the Consulate General of Israel in the HKSAR before travelling.

Remark 14: Holders of a valid HKSAR passport enjoy visa-free access to enter Japan for the purpose of short-term visits of up to 90 days. This exemption does not apply when the visit is for purposes other than a short term visit, such as seeking employment or exercising a profession or other occupation. However, visa fees for these kinds of visits where a visa is required will be waived.

Remark 15 : Regarding the requirement of notification of arrival of a foreign citizen (including holder of HKSAR passport) to Kazakhstan, as well as about the change of

residence, please refer to the website: https://egov.kz/cms/en/articles/exit-entry_of_foreign_nationals for details.

Remark 16 : According to the information provided by the Honorary Consulate of the Republic of Kenya (Kenya) in the HKSAR, the Government of Kenya has developed and is operating an Electronic Travel Authorisation (eTA) System that determines the eligibility of visitors to travel to Kenya. Holders of HKSAR passport of all ages are required to obtain eTA prior to travel to Kenya via an online platform. For details, please refer to the website: <http://www.etakenya.go.ke>.

Remark 17: The Government of the Republic of Korea (Korea) previously announced that visa-free passport holders (including holders of HKSAR passport) should hold a Korea Electronic Travel Authorization (K-ETA) before boarding aircrafts or ships bound for Korea. With effect from 1 April 2023 until 31 December 2025, the requirement of holding K-ETA is temporarily exempted for holders of HKSAR passport. For details and latest arrangement, please refer to the website: www.k-eta.go.kr.

In case of enquiry, holders of HKSAR passport are advised to consult the Consulate General of the Republic of Korea in Hong Kong before travelling.

Remark 18 : According to the information provided by the Embassy of the Kyrgyz Republic (Kyrgyzstan) in the People's Republic of China, HKSAR passport holders may visit Kyrgyzstan visa-free for a stay of up to 30 days entering through Manas International Airport in Bishkek with a return air ticket and re-enter after 30 days from the date of departure from Kyrgyzstan. Foreign visitors (including HKSAR passport holders) who visit Kyrgyzstan visa-free are required to enter and depart from Kyrgyzstan through Manas International Airport in Bishkek with a return air ticket departing from Manas International Airport. In case of enquiry, HKSAR passport holders are advised to consult the Embassy of Kyrgyzstan in the People's Republic of China before travelling.

Remark 19 : HKSAR passport holders can apply for a visa upon arrival at Lao International Airports or Lao International border checkpoints for tourist purpose.

Remark 20 : According to the information provided by the Government of Malaysia, all visitors (including holders of HKSAR passport) travelling to Malaysia are required to complete the Malaysia Digital Arrival Card (MDAC) within three days prior to their scheduled arrival in Malaysia. For details regarding the nationality options upon MDAC application and points to note during immigration clearance by holders of HKSAR passport, please refer to the website: https://www.kln.gov.my/web/chn_hong-kong/requirement_foreigner. In case of enquiry, holders of the HKSAR passport are advised to consult the Consulate General of Malaysia in the HKSAR before travelling.

Remark 21 : HKSAR passport holders can apply for a visa upon arrival at the Nouakchott International Airport or the land border crossing checkpoint in Nouadhibou.

Remark 22 : According to the Embassy of Mozambique in the People's Republic of China, holders of the HKSAR passports can apply for the tourist visa upon arrival in Mozambique for a stay of 30 days. HKSAR passport holders are advised to consult the relevant embassy or consulate for detailed information before travelling.

Remark 23 : According to the information provided by the Consulate General of the Republic of the Union of Myanmar, starting from 11 March 2024, the Government of the Republic of the Union of Myanmar has launched Tourist Visa on Arrival for holders of the HKSAR passport. Upon arrival at International Airports of the Union of Myanmar, holders of the HKSAR passport may apply tourist visa for a stay of 30 days. Holders of the HKSAR passport are advised to consult the Consulate General of the Republic of the Union of Myanmar in the HKSAR and refer to the website: <https://www.myanmarconsulatehk.org/index.php/visa/visa-on-arrival> for details before travelling.

Remark 24 : According to the information provided by the Government of New Zealand, starting from 1 October 2019, visitors and transit passengers who are eligible for visa waiver (including holders of HKSAR passport) are required to hold a New Zealand Electronic Travel Authorization (NZeTA) before travelling to New Zealand. For details and application arrangements, please refer to the website: www.immigration.govt.nz/nzeta. In case of enquiry, HKSAR passport holders are advised to consult the Consulate General of New Zealand in Hong Kong before travelling.

Remark 25 : Starting from 28 November 2009, other than a valid HKSAR passport, holders are also required to present their valid Hong Kong permanent identity cards upon arriving in the Northern Mariana Islands.

Remark 26 : According to the information from the Honorary Consulate of the Sultanate of Oman (Oman), HKSAR passport holders may visit Oman visa-free for a stay of up to 14 days. For details, please refer to the website: www.fm.gov.om. In case of enquiry, HKSAR passport holders are advised to consult the relevant embassy or consulate before travelling.

Remark 27 : The Palau authority has reconfirmed on 24 March 2009 that holders of HKSAR passport can apply for an entry permit-on-arrival, free of charge, for a stay up to 30 days upon arrival in Palau.

Remark 28 : Regarding the requirements for HKSAR passport holders to enjoy visa-free access to visit Qatar, please refer to the website: <https://hongkong.consulate.qa/en/services/consular-services#visa-free-arrival-foe-30-days>. HKSAR passport holders are advised to consult the Consulate General of The State of Qatar in the HKSAR for detailed information before travelling.

Remark 29 :

(1) Russia grants holders of HKSAR passport visa-free access up to 14 days. According to the information from the Chinese Embassy in Russia (Embassy), the duration of stay concerned should be counted starting from the date of entry. Those who fail to depart before the end of the duration of stay granted may commit an offence under the local law. For details, please refer to the website:

(2) According to the information from the Embassy, if HKSAR passport holders intend to stay for more than 7 days after arrival, they should approach the local branch of the Federal Migration Service within 7 days of arrival for registration formalities. Most major hotels will register for their guests. Before travelling, HKSAR passport holders are advised to consult the Consulate General of Russia in Hong Kong for detailed information.

Remark 30 : HKSAR passport holders can only apply for a tourist visa upon arrival through six designated control points/ports (including King Khalid International Airport in Riyadh, King Abdul-Aziz International Airport in Jeddah, King Fahad International Airport in Dammam, Prince Mohammed bin Abdul-Aziz International Airport in Medinah, King Fahad Bridge Land Port and Al Bathaa Land Port) in Saudi Arabia. HKSAR passport holders can apply for (i) single entry visa with 90 days validity for a maximum stay of 30 days; or (ii) multiple entry visa with one-year validity for a maximum stay of 90 days. HKSAR passport holders are also eligible to apply for eVisa to visit Saudi Arabia prior to the visit. For details, please refer to the website: <https://visa.visitsaudi.com>.

Regarding the health-related information for HKSAR passport holders travelling to Saudi Arabia, please refer to the website: www.moh.gov.sa. HKSAR passport holders are advised to consult the Consulate General of Saudi Arabia in HKSAR for detailed information before travelling.

Remark 31 : According to the information from the Department of Home Affairs of South Africa, effective from 1 June 2015, all children under 18 years of age, travelling to or departing from South Africa must produce the birth certificate of children and, if necessary, other relevant document(s). Before travelling, HKSAR passport holders are advised to consult the Consulate General of South Africa in Hong Kong for detailed information.

Remark 32 : Starting from 1 May 2025, all non-Thai nationals (including HKSAR passport holders) entering Thailand are required to complete the Thailand Digital Arrival Card (TDAC) online within three days before arrival. For details, please refer to the website: <https://tdac.immigration.go.th>. In case of enquiry, HKSAR passport holders are advised to consult the Royal Thai Consulate General in the HKSAR before travelling.

Remark 33 : HKSAR passport holders can apply for a visa upon arrival at the International Airport in Dili or Dili Sea Port.

Remark 34 : HKSAR passport holders can apply for a visa upon arrival at the international airport in the Kingdom of Tonga.

Remark 35 : The Government of the United Kingdom (UK) introduced the Electronic Travel Authorisation (ETA) scheme for those passengers visiting or transiting the UK, who do not currently need a visa for short stays or do not have a valid UK immigration status prior to travelling. ETA will be required for HKSAR passport holders travelling to the UK starting from 8 January 2025. In case of enquiry, HKSAR passport holders are advised to consult the British Consulate General in the HKSAR before travelling.

Remark 36 :

(1) With effect from 1 March 2021, HKSAR passport holders enjoy visa-free access to visit Uzbekistan for a stay of up to 10 days upon arrival in the presence of an air ticket to the third countries or a return air ticket. The visa-free access is exclusively applicable to air travel for entering and departing from Uzbekistan. HKSAR passport holders entering and departing from Uzbekistan via land borders are required to apply tourist e-visa. For details, please refer to the website: <https://e-visa.gov.uz>.

(2) HKSAR passport holders aged 55 or above who enter the country with a tour group can stay for 30 days without a visa. HKSAR passport holders aged under 16 who are accompanied by a legal guardian can enter Uzbekistan without a visa for a stay not exceeding 90 days. In case of enquiry, HKSAR passport holders are advised to consult the Embassy of the Republic of Uzbekistan in the People's Republic of China before travelling.

Remark 37 : The Venezuelan Government has extended to HKSAR passport holders the 'Tourist Card' System, which allows Venezuelan Tourist Card holders visa-free visits to Venezuela for 90 days.

Remark 38 : According to the information provided by the Government of Zimbabwe, Hong Kong SAR passport holders visiting Zimbabwe enjoy visa free entry up to a maximum stay of 6 months for holiday purpose. For business purpose, HKSAR passport holders enjoy a maximum of 1 month visa free entry, after which they should apply for a work permit. In case of enquiry, HKSAR passport holders are advised to consult the Consulate General of Zimbabwe in Hong Kong before travelling.
